Commitment to achieving Net Zero

Gardamed Limited is committed to achieving Net Zero emissions by 2050.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Baseline Year: 2022/2023 (1st April 2022 – 31st March 2023)

Gardamed Limited is engaged in the distribution, stockholding, purchasing, marketing and sales of compression and elastic garments, anti-embolism stockings, intermittent pneumatic pumps with sleeves and stocking application aids. Gardamed Limited does not undertake any manufacturing or production processes. 2022/2023 is our baseline year and we used the Carbon Footprint Calculator tool to establish our Scope 1 and Scope 2 emissions. Gardamed makes the use of communal offices for meetings and the employees currently work from home.

Scope 1: includes all direct emissions that are generated from sources that are directly owned or controlled by Gardamed including computers, vehicles etc.

Scope 2: includes indirect emissions from the generation of the electricity purchased and used by Gardamed.

Scope 3: includes all indirect emissions that occur in Gardamed's value chain which we do not own or control. These include purchased materials, incoming shipments, national deliveries. We used third party information from suppliers and service providers. For the Baseline year some of this information is still outstanding.

- Gardamed worked with non UK suppliers to reduce their own carbon emissions by 50%

- 3. Adoption of electric vehicle company car policy
- 4. Investigating freight competitors for carbon emissions in order to source the lowest
